While welcoming positive aspects of the European Commission's work programme for Health research in 2014-2015 (Horizon2020), all associations signing this agreement are deeply concerned about the balance of priorities and we call for a major revision of this work programme.

# Policy Brief 'Strengthening the European dimension of health services research'

The EUPHA Section on HSR and the network HSR Europe have published a policy brief, which contains a summary of lessons based on their working conference, prior to the EPH Conference in Malta. It addresses the importance of internationally comparative HSR both for

individual countries as well as the EU research agenda of Horizon 2020. In a nutshell, we mostly need:

- a broader research chain from research lab to real-life implementation
- to use Europe as a natural laboratory for health services and systems research
- to move from centres of excellence to a sector of excellence
- · to synchronize national and European research agendas
- to better monitor the societal impact of health services research
- better training in transferring knowledge in order to realise more evidence informed policies
- capacity building in countries with less HSR potential

From eHealth to mHealth: Society becomes the driver of its health activities – call for papers.

The further use of wireless internet and gadgets that receive and transmit data (tablet computers and laptops) have constituted a new trend for eHealth providing for more on-the-spot services. What came to be known as mHealth is a developing trend in the eHealth field that encompasses and exploits the broadening use of mobile telecommunications and multimedia technologies as they are integrated within increasingly mobile and wireless healthcare delivery systems.

This new area of mobile health has the transformative power to fully revamp the healthcare sector, by changing behaviours or environmental exposures that can reduce health risks or optimise health outcomes. This happens mainly for two reasons. First, mHealth has the potential to change the when, where, and how healthcare is provided, operating on a 24/7 basis. Second, it can ensure that important social, behavioural, and environmental data are effectively used to comprehend health determinants.

The European Journal of ePractice seeks high-quality contributions for a special issue on mHealth. The issue will discuss and highlight potentials, opportunities and risks deriving from mHealth application and promotion.
